# From the Desk of the Director

n 14<sup>th</sup> May, 2012, Hon'ble Shri Justice Altamas Kabir, Chief Justice of India (former) laid the Foundation stone for the Sikkim Judicial Academy at Sokeythang, East Sikkim. Thereafter, on 02.06.2013, the Sikkim Judicial Academy was inaugurated in the present building in the High Court premises by Hon'ble Mr. Justice Altamas Kabir, Chief Justice of India (former) and from where it has been temporarily functioning so far. Just over a year old, it is still in a nascent stage with all the consequent trials and tribulations. Nonetheless, for the Academic year, 2014, we have hopefully charted out a series of training programmes that strives to meet the aims and objectives of the Sikkim Judicial Academy as set out in our Profile.

The Sikkim Judicial Academy is unique in that the training programmes organised are not only for Judicial Officers but for all stake holders in the justice delivery system. We have programmes designed for Judicial Officers, Advocates with upto 5 years of practice, Juvenile Justice Board Members and Panel Advocates, Police Officers, Public Prosecutors, Members of the Consumer Fora and State department officers as well as the ministerial staff of the Courts.

The object of the programmes is not only to impart training on various aspects of law and justice administration, but also to sensitize participants on various issues such as women, children, environment, marginalized sections of society and the emerging trends in the legal arena. The programmes for the Judicial Officers are specially designed to equip them with skills to enable them to render quality justice in the cases which come before them for adjudication. In the training for the police force, public prosecutors and the members of the Bar, particularly, the novice members; the Sikkim Judicial Academy aims to similarly sensitise them and train them so that they are able to contribute constructively to the justice delivery system.

The training programmes therefore, cover a wide range of topics from enhancing the quality of adjudication, to judicial accountability, Case Management, administration of Justice in Subordinate Courts, appreciation of local laws, the Constitution, Criminal and Civil laws and other emerging laws.

The Sikkim Judicial Academy endeavours to make the programmes engaging and thought provoking and hopes the efforts are reflected in the development of the Officers and in the discharge of their duties. As Queen Elizabeth II of Britain once said, "It's all to do with the training: you can do a lot if you're properly trained."

The 'Orientation-cum-Training/Sensitization Programme' (P1) was the first programme held for the academic year 2014 at Sikkim Judicial Academy for Advocates upto 5 years of Practice on April 26-27, 2014.

It was organised under the guidance of the Hon'ble Patron-in-Chief and the President. This programme focussed on the growing need of upholding standards of professional conduct and etiquette. The Advocates Act, 1961, the High Court of Sikkim (Condition of Practice) Rules, 2006, the Bar Council of India, Rules were also discussed.

Other basics of essentials for new entrants to the Bar, such as rights of a person when arrested, bails/remand, FIR, Charge, Charge sheet etc. basics of CPC plaint, pleading etc, the Legal Service Authority Act, 1997 ADR methods: Mediation, Conciliation & Judicial Settlement with reference to Section 89 CPC, Protection of Women from Domestic Violence Act, 2005, Juvenile Justice Child Care & Protection Act, 2000 were also covered.

The Resource persons for the programmes were Senior Advocates Shri K. T. Bhutia & Shri N. Rai and Advocates Shri S. S. Hamal & Shri U. P. Sharma.

Training was imparted to 28 Advocates with upto 5 years of practice.


