Workshop on Criminal Investigation- Preparation of Chargesheet and Issues relating to Advances in Forensic Science for Police Officers

In the first session Shri N.P. Sharma discussed in details contents of charge-sheet. He stated that the charge-sheet must be detailed and must include all the steps taken as well as the steps not taken during investigation. The other important provisions and steps to be taken were highlighted by the Resource Person.

The second session was taken by Dr. R.P.Gohain. In this session the Resource



Person informed the participants the application of forensic sciences as practical tools to help the police in conducting investigations. He discussed Finger-print matching, DNA analysis, Chemical analysis, etc.

The object behind the Workshop was to sensitize the Special Prosecutors and the Advocates as well as to better understand the psychology of a child victim. The first session was by the Hon'ble Mrs. Justice Dr. Shalini Joshi. Hon'ble Ladyship gave a brief background on the POCSO Act. It was informed that the POCSO Act expands the definition of Sexual Abuse inflicted upon a child. The Act includes both sexual harassment and child pornography as an offence. The Procedure involved during examination of a child was discussed in detail. Rule 7 of the POCSO Rules on compensation was discussed in great length.

In the second session Dr. Sonam Ongmu discussed in detail the ways to examine a child who is a victim of sexual assault. It was informed that the main objective was to create a safe environment for the child for her to be able to disclose the unfortunate incident. Various details such as types of questions which could be asked, body posture, etc., were discussed in detail.



26<sup>th</sup> July, 2019

Workshop on Protection of Children from Sexual Offences Act, 2012 (POCSO Act) for Chief Judicial Magistrate and Judicial Magistrates of the State.

The Workshop was organized to sensitize the Magistrates who are involved in recording the statement of the child victim under Section 164, Code of Criminal Procedure. Further, some of the Judicial Magistrates also function



as Principal Magistrates of the Juvenile Justice Boards of the various Districts. Object was to have a better understanding of the psychology of the victim child. There were three sessions.

The Resource person for the first and second sessions was Miss Bharti Ali. The Resource Person informed that the statements of the victim under Section 164. Code of Criminal Procedure, 1972, must be in the language of the victim. The procedure to be followed and the best way to record the statement of the victim was discussed in detail. Further, discussion was also made, by referring to a number of landmark judgements of the Hon'ble Supreme Court, on the type of questions which could be put forth to a child

victim.A detailed discussion was also made on the Protection of Victim Scheme. It was suggested that this scheme ought to have been a part of the POCSO Act itself.

The Resource Person informed that the Judge has the power to grant interim compensation to a victim under the POCSO Rules being Rule 7 in particular. That compensation can be granted under Section 33 of the POCSO Act. Further all children in conflict with law are also children in need of care and protection. There was a detailed discussion on preliminary assessment of the child in conflict with law under Section 15, Juvenile Justice (Care & Protection of Children) Act, 2015. The definition of "Heinous" crime was also looked into in detail.

The Resource person for the third session was Dr. Sonam Ongmu Lasopa. In the session the doctor discussed in detail the ways to examine a child who is a victim of sexual assault. It was informed that the main aim was to create a safe environment conductive for the child to be able to disclose the unfortunate incident. Various details such as the types of questions which could be asked, body posture, etc. were discussed in details.





Workshop on Motor Vehicle Act, 1988 vis-à-vis, The Central Motor Vehicle Rules 1989 and The Sikkim Vehicle Rules, 1991 for District & Sessions Judges and Officers from State Transport Department.

#### **RESOURCE PERSON:**

Mr. Ashwinin Kumar Matta. New Delhi was the Resource Person.

The first Workshop was on "Motor Vehicle Act, 1988 vis-a-vis The Central Motor Vehicle Rules, 1989 and The Sikkim Motor Vehicle Rules, 1991" and the second Workshop was on "Recent



Developments in Commercial Law and Law of Arbitration". The Resource Person discussed all the important provisions of the Motor Vehicle Act, 1988. It was informed that alteration of vehicles by way of modification was not allowed. On aspect of Compensation, it was informed that the Hon'ble Supreme Court in Ramlav. National Insurance (2019(2)SCC



192) held that the Tribunal can award higher compensation than claimed if it is fair. Approach of every Tribunal ought to be benevolent. Various situations where a victim is entitled to compensation was discussed. It was informed that "Permanent disability" as given under Section 163A of the Motor Vehicle Act, 1988 is the same as defined under

the Workmen's Compensation Act. The Resource Person also discussed briefly the Bill tabled before the Parliament.

In the second session on "Recent Developments in Commercial Law and Law of **Arbitration**", the Resource Person discussed the important provision of the Arbitration & Conciliation Act, 1996. It was informed that the issue of Jurisdiction must be taken up at the initial stage otherwise it shall be deemed to be waived. Further, the Tribunal has the power to give award under the Specific Relief Act, 1933. That the Arbitrator is the master if procedure empowered to determine the facts. It was informed that for extension of time, if a party is not a clause on time limit, even then the Court can intervene in the interest of Justice. That an award once granted can be challenged within 90days before the Civil Court.



# 5<sup>th</sup> August, 2019 Training Programme on Indian Evidence Act, 1872 for Judicial Officers.

The Hon'ble Resource Person discussed all the important topics of the Evidence Act namely Resgestae, types of evidence, estoppels, admissions and confessions. While touching upon the topics, the Hon'ble Resource Person also discussed Landmark judgment and gave analogies.



17th August, 2019.

Workshop on The Narcotic Drugs and Psychotropic Substances Act, 1985 (NDPS) and Sikkim Anti Drugs Act (SADA) and Prevention of Corruption Act. 1988, Prevention of Money Laundering Act, 2002 for Sessions Judges.



#### **RESOURCE PERSONS:**

- 2. Ms. Mehak Jain, Superintendent, Narcotics Control Bureau (NCB) New Delhi.



There were two Workshops organised this day. The first was on Sikkim Anti Drugs Act, 2006, and the Narcotic, Drugs and Psychotropic Substances, Act, 1985. The Resource Person for this was Miss Mehak Jain. In this session the Resource Person discussed the similarities and differences between Sikkim Anti Drugs Act, 2006, and the Narcotic, Drugs and Psychotropic Substances, Act, 1985. Sikkim Anti Drugs Act, 2006, was enacted as the Narcotic, Drugs and Psychotropic Substances, Act, 1985 did not have much control over prescription drugs. It was informed that attempt to commit an offence is not on offence under Sikkim Anti Drugs Act, 2006 unlike the Narcotic, Drugs and Psychotropic Substances, Act, 1985. Many landmark Judgments were discussed.

The second session was on The Benami Transaction (Prohibition) Act, 1988. The Banker's Books Evidence Act, 1891. Prevention of Corruption Act, 1988 and The Prevention of Money Laundering Act, 2002. The Resource Person was Hon'ble Mr Justice Bibek Chaudhari. Hon'ble Resource Person discussed various judgments under The Benami Transaction (Prohibition) Act, 1988. Under The Benami Transaction (Prohibition) Act, 1988, Hon'ble Resource Person discussed Section 65B, Indian Evidence Act, 1872 along with The Benami Transaction (Prohibition) Act, 1988. Here also he referred to a number of important judgment. Under the Prevention of Corruption Act, 1988, Hon'ble Resource Person informed that Sections 7,11 and 13 are the most important sections under the Act. It was informed that the sanction as defined under Section 19 of the Act is not the same as defined under Section 197, Code of Criminal Procedure, 1973. Various instances where sanction is necessary to prosecute as well as to investigate was discussed. Under The Prevention of Money Laundering Act, 2002, Hon'ble Resource Person highlighted the important provisions of the Act. He mentioned that under the Act the Court can order for attachment of property but not for satisfaction. That the property can be confiscated only if found guilty.



23<sup>rd</sup> August, 2019

Workshop on Protection of Women from Domestic Violence Act, 2005, Negotiable Instrument Act, 1882 and Bankers Book Evidence Act, 1891 for Chief Judicial Magistrates and Iudicial Magistrates.

#### **REOURCE PERSON:**

Hon'ble Shri Justice Jay Sengupta, High Court of Calcutta.

The Hon'ble Resource Person while discussing The Protection of Women from Domestic Violence Act. 2005 shared a number of important Judgments on varied issues. It was informed that in Chattur bhuyer. Sita Bai (2008)2 SCC 316) it was held that Women are entitled to enjoy the



same standard which she was enjoying in her husband's house. This is also enshrined in Section 20(2) of the Protection of Women from Domestic Violence Act, 2005. That even a childless



step-mother can claim for maintanence from her step-son. Hon'ble Resource Person also discussed Maintenance of Muslim Women and shared a number of Judgments of the Hon'ble Apex Court.

Under the Negotiable Instrument Act, 1881. Hon'ble Resource Person discussed all the important provisions of the Act. That complaint under Section 138 of the Act can be filed by a Power of Attorney holder provided the attorney holder has knowledge of the transaction. Further,

evidence of the complainant and his witnesses can be filed on evidence. On the issue of vicarious liability of a person, it was informed that the same must be mentioned by the

petitioner in his petition. Further such person his innocence and get the proceeding quashed by the Court. That in case of two notices, one within time and the second sent after lapse of the time period, it was held in ((2017)5 SCC 737) that the second notice must be treated as a reminder to the first notice. While discussing all the important provisions, the Hon'ble Resource Person discussed all the important judgments.

The first session was on "Medico Legal opinion in cases of rape, murder, death by poisoning, cases under Section 307, Indian

Penal Code, appreciation of evidence on post mortem, ante mortem and post mortem injuries, etc." The Resource Person was Dr. Anil Agrawal. During the session the Resource Person discussed all the topics with cases he had handled in his 45 years of practice as a





Medical Practitioner. He also informed of safe kits provided by the Government of India for collection of evidence of survivors of Sexual Assault as well as of the accused. He shared videos to demonstrate how the kit was to be used while collecting evidence. It was mentioned that the kit was launched in 2008 and the distribution gained greater momentum after the Nirbhaya case of 2012.

The second session was on "Preservation of viscera, Forensic evidence, collection of DNA sample/sampling, scientific tools to investigate cases and collection of sample in NDPS Cases". The Resource Peson was Dr. Jitesh Bhatia, The Resource Person shared the latest methods practiced in the country for collection of sample under the Narcotic, Drugs and Psychotropic Substances Act, 1985. He also discussed in detail the importance of DNA sample collection and the method of collecting the same.
