




"Court Decorum and Etiquette in Courts, Professional Ethics & Advocacy"




Sikkim Anti Drugs Act, 2006 is a special Act for the State of Sikkim enacted primarily to curb abuse of prescription drugs. As the cases under this Act have been rising manifold and as this Act contains several procedures to be followed during investigation, a programme under SADA, 2006 vis-a-viz NDPS Act, 1985 was felt inevitable.

Mr. N.P. Sharma, Special Public Prosecutor & Sr. Government Advocate was the Resource Person. Investigating Officers were provided with the knowledge of correctly interpreting the provisions of the Acts and the manner of investigating cases of these nature.






