2. Android Application 'High Court of Sikkim' provides a single window to access case status anywhere, anytime.

3. Case Information SMS notification application is used to send case status related SMS to Advocates and Litigants.

4. Information Kiosks has been installed in the Court Complexes to enable self-service.
